Businesses include Apple SoHo (located at 103 Prince St, New York, NY 10012), Everlane (located at 28 Prince St, New York, NY 10012) and Patagonia SoHo (located at 72 Greene St, New York, NY 10012).

8. The heartfelt dedication and enthusiasm of the core group of volunteers, which is made up of neighbors, community members, and businesses, reflects the immense importance of the Garden.
